Multigram scale preparation of a semi-synthetic N-trifluoroacetyl protected chondroitin

disaccharide building block: towards the stereoselective synthesis of chondroitin sulfates

disaccharides

Abstract: the chemoselective N-trifluoroacetylation of a chondroitin disaccharide obtained from

controlled acid hydrolysis of a commercially available polymeric chondroitin sulfate is reported for the

first time. We also described the multi-gram scale synthesis of a donor block having a benzylidene

moiety further used for the expeditious and stereocontrolled synthesis of glycosides fitted with various

aglycons. Stereocontrolled β-glycosylation, sulfation and efficient N-TFA deprotection steps afforded

the desired disaccharides in good yields.

1. Introduction

Chondroitin sulfates (CS) are heteropolysaccharides that belong to a family of complex,

polyanionic polymers called glycosaminoglycans (GAGs). CS are ubiquitously present on the cell surface

as well as in the extracellular matrix. They consist of a repeating disaccharide unit (with a highly

variable molecular weight) composed of a D-glucuronic acid (D-GlcA) and a 2-acetamido-2-deoxy-D-

galactose (D-GalNAc) and contain, on average, one sulfate group per disaccharide unit. The most

commonly sulfated positions are positions 4 (CS-A) and/or 6 (CS-E and CS-C, respectively) of the D-

GalNAc moiety. Due to their rich structural diversity and to their various sulfation patterns, CS play an

important role in numerous biological processes (neuronal development, morphogenesis,

inflammation...)<sup>2</sup> through their interaction with a large variety of binding proteins. Thus, there is a great

demand of well-defined oligosaccharides fragments of CS; however, due to their complex structure,

their synthesis is not trivial. During the last decade, we developed an original and straightforward

method for the preparation of CS oligosaccharides by semi synthesis starting from commercially

available CS polymers.<sup>3</sup> This step-economic process allows the synthesis of the key intermediate 1 possessing the basic repeating unit of CS (D-GlcA-D-GalN) (Scheme 1). This disaccharide 1 is a polyhydroxylated compound with an ester moiety and is poorly soluble in organic solvents thus rendering its N-chemoselective protection difficult. So far, the trichloroacetyl (TCA) group, known to be a good auxiliary in synthesis of 1,2-trans-2-amino-2-deoxy sugars, is the only N-protecting group introduced on disaccharide 1. For example, our group described the multi-gram scale synthesis of a key disaccharide 2, bearing the N-TCA, a benzylidene and acetyl protecting groups as the starting material for the synthesis of a large library of well-defined CS oligosaccharides.<sup>4</sup> However, the reduction of the TCA group at the end of the synthesis into its N-acetyl analog (radical conditions or using Zn-Cu couple) does not always go to completion and mono- or dichloroacetamide species are often isolated. Moreover, those deprotection conditions are not compatible with all kinds of aglycons such as azide or alkene/alkyne moieties for example. Trifluoroacetyl group (TFA) has been described for the synthesis of various 2-acetamido-2-deoxy compounds and has shown to be an efficient auxiliary for stereocontrolled glycosylation easily removed by basic treatment.<sup>5</sup> Thus, TFA group could be envisaged as a good alternative to TCA group but it has rarely been used in CS oligosaccharides and all the synthetic strategies were based on the use of monomeric units as starting materials (NH-TFA galactosamine and glucuronic acid building blocks). <sup>6</sup> This is why, we report here for the first time a new synthetic pathway which is the gram-scale synthesis of the new key disaccharide building block 3 (Scheme 1) bearing the TFA group, starting from disaccharide 1 using our semi-synthetic strategy. Transformation into one fully deprotected 4-sulfated (CS-A) disaccharide bearing N-acetyl group is also reported as a proof of concept.

#### 2. Results and discussion


Starting disaccharide methyl ester **1** was prepared by acid hydrolysis of CS polymer, followed by esterification using our usual hemisynthetic process.<sup>3</sup> In order to synthesize fully-protected compound **3**, we then investigated the chemoselective *N*-trifluoroacetylation of **1** to obtain intermediate **4** (Scheme 2 (pathway 1, step a), Table 1) that will further be transformed into the target compound. We first envisaged to apply similar conditions to those reported for the chemoselective transformation into *N*-TCA *i.e.* the use of a large excess of acylating reagent in pyridine (Table 1, entry

1).3 Regarding the TCA protection, those conditions allowed the formation of a transient total O,Npertrichloroacetylated compound soluble in organic solvent. Aqueous work up to remove the watersoluble side-products followed by selective solvolysis gave only the N-TCA product. However, in the present trifluoroacetylation process, this attempt using excess of (CF<sub>3</sub>CO)<sub>2</sub>O failed and only traces of the compound 4 were observed. This is probably due to the lability of the O-C(O)CF<sub>3</sub> bond which is hydrolyzed during the work up thus leading to the loss of the polyhydroxylated compound in the aqueous phase. In order to limit salts formation and to avoid the extraction step, the number of equivalents of (CF<sub>3</sub>CO)<sub>2</sub>O was decreased but once again, only traces of 4 were observed after purification on silica gel (Table 1, entry 2). Changing the base to triethylamine (NEt<sub>3</sub>) did not improve this reaction (Table 1, entries 3 and 4). Better results were obtained using ethyl trifluoroacetate as acylating agent with NEt<sub>3</sub> or Na<sub>2</sub>CO<sub>3</sub> as the base in MeOH: we were thus able to isolate the desired disaccharide 4 in reasonable quantities (Table 1, entries 5-7). However, it has to be noted that most of the time, the compound could never be obtained in pure form, even after chromatographic purification (normal or reverse phase), and that it was usually accompanied by unseparable byproducts (salts). We nevertheless treated this impure compound with benzaldehyde and trifluoroacetic acid (to install the benzylidene group), followed by an in situ peracetylation (Scheme 2 (pathway 1, step c)) and the target fully-protected disaccharide 3 was isolated after purification in 19% yield over 3 steps from 1.


Considering the difficulties to isolate the intermediate **4** pure, we then concentrated our efforts on the direct synthesis of disaccharide **3** (from **1**) using the crude compound **4** (direct pathway 2). To this end, we tried various trifluoroacetylation conditions (Scheme 2 (pathway 2, step b), Table 2) and after a simple evaporation of the reaction, the crude mixture was directly engaged in the benzylidene formation and acetylation steps (Scheme 2 (pathway 2, step c)). By following this direct strategy, we could finally observe the target compound **3** using (CF<sub>3</sub>CO)<sub>2</sub>O (in pyridine or in MeOH with triethylamine) showing that the *N*-protection occurred (Table 2, entries 1-2). However, we were not able to obtain a pure compound and a significant amount of by-products was observed. As before, changing the acetylating agent for ethyl trifluoroacetate (Table 2, entries 3-6) led to better results and the best conditions (Table 2, entry 6) allowed us to isolate the pure disaccharide **3** with 33% yield from **1**. Interestingly, this direct pathway has been extrapolated with the same yield on large-scale and 13 g of **3** were obtained starting from 22 g of **1**. In comparison, 17 g of NH-TCA protected disaccharide **2** was usually obtained from 22 g of **1** (40% yield).<sup>4a</sup>

Starting from disaccharide **3** we next envisaged to synthesize various disaccharides. To this end, and in order to introduce various aglycons, we first activated the anomeric position with a trichloroacetimidate moiety and we obtained in two steps the crystalline  $\alpha$ -trichloroacetimidate disaccharide **5** in 59% yield using classical conditions<sup>7</sup>(Scheme 3). Despite the presence of a participating group at C-2, donors derivatives in D-galacto series bearing a 4,6-benzylidene are known to lead to mixture during the glycosylation step.<sup>8</sup> This is explained by the constraint of the 1,3-dioxolane ring that hinders the  $\beta$ -face. In 2009, we showed that it was possible to circumvent this problem using of a soft Lewis acid (boron trifluoride ethyl etherate) at low temperature and we were able to obtain mainly 1,2-trans-linked glycosides starting from a disaccharide having NTCA and benzylidene moieties.<sup>4a</sup> Applying those glycosylation conditions on NTFA disaccharide **5** in the presence of different alcohols (3-bromopropanol, *O*-(2-azidoethyl)triethylene glycol and 2-napthylmethanol), successfully afforded only the corresponding 1,2-trans-glycosides **6a-c** in 35-55% yield (no traces of the 1,2-cis analog could be observed) (Scheme 3).

Within the frame of a program devoted to the study of cathepsin K (Cat K), a collagenolytic protease involved in osteoporosis disease, we are particularly interested in the synthesis of short 4-sulfated chondroitin (CS-A) oligomers as new tools to understand the enzymatic mechanism of Cat K. We thus envisaged to take advantage of the presence of the benzylidene group to differentiate positions 4 and 6 and to synthesize the 4-sulfated disaccharide **10** (Scheme 4). To this end, an acidic hydrolysis of benzylidene acetal was first performed and diol **7a** was isolated in 70% yield. Regioselective 6-*O*-benzoylation using benzoyl cyanide followed by 4-*O*-sulfonation with sulfur trioxide-trimethylamine complex gave the sodium salt **9**. Final two-step saponification<sup>9</sup> process with lithium hydroperoxide and sodium hydroxide followed by *N*-acetylation afforded the desired 4-sulfated disaccharide **10** in very good yield, thus showing the ease of deprotection of TFA.

In order to validate the choice of TFA as a protecting group we also considered the full deprotection and conversion of NHTFA into NHAc of disaccharides carrying aglycons that would be affected during NHTCA reduction. To this end, we focused on disaccharides **6b** and **6d** (obtained from the corresponding bromo derivatives **6c** in excellent yield) that both possess an azido terminal group. As previously, hydrolysis of the benzylidene acetal under acidic conditions afforded diols **7b** and **7d**. Two-step saponification followed by selective *N*-acetylation successfully afforded unprotected disaccharides **11b** and **11d** still bearing the azido group in good yields thus confirming again the interest to install the TFA protecting group on our hemi-synthetic disaccharide **1**.

#### 3. Conclusion

In conclusion, *N*-TFA protected disaccharide **3** could be prepared on gram-scale from efficient chemoselective protection of a crude chondroitin disaccharide obtained from a hemisynthetic pathway from CS polymer. This enlarges the scope of this process, reported so far solely with a TCA protecting group, thus offering the possibility of working with aglycons labile under TCA deprotection conditions such as azido moieties. Starting from this key building block **3**, we described the synthesis of the elaborate 4-sulfated disaccharide **10**, which is currently under evaluation on Cathepsin K. Finally, stereoselective glycosylations and conversion of TFA into acetyl group could be validated. The synthesis of longer oligosaccharides using this attractive and efficient process is now under study.

#### 4. Experimental

#### 4.1. General methods

Commercial solvents and reagents were purchased from Sigma-Aldrich, Acros, Alfa-Aesar, TCI, Carbosynth and Fluorochem suppliers and were used without further purification unless otherwise stated. Anhydrous solvents were dried by standard methods: DCM was distilled over  $P_2O_5$ , THF and acetonitrile were purified with a dry station GT S100 immediately prior use; DMF, methanol and toluene were dried over molecular sieves. Molecular sieves were activated by heating overnight in an Erscem oven at 500°C. Hydrazine acetate was recristallised in methanol prior to use. For the anhydrous reactions, all glassware was dried in an oven overnight (100°C), then removed and cooled down to rt under argon flow. Argon flow was dried with a solution of conc.  $H_2SO_4$  solution and CaCl<sub>2</sub>.

Flash silica column chromatography was performed on silica gel 60N (spherical neutral, 40-63  $\mu$ m, Merck). The reactions were monitored by thin layer chromatography (TLC) on silica gel 60F254 precoated aluminium plates. Compounds were visualised under UV light ( $\lambda$ = 254 nm or  $\lambda$ =365 nm) and by charring with a 10% H<sub>2</sub>SO<sub>4</sub> ethanolic solution or Hanessian's stain.

Infrared spectra (ATR) were recorded on a Perkin-Elmer PARAGON 1000 PC instrument and values are reported in cm<sup>-1</sup>. Mass Spectra were performed on a Perkin-Elmer Sciex API 300 mass spectrometer (low resolution) and a Bruker MaXis Q-Tof (High resolution) from the "Federation de Recherche" ICOA/CBM FR2708 platform in the electrospray ionisation (ESI) mode. Melting points were determined in open capillary tubes using a Buchi Melting Point B-545 apparatus and values are uncorrected. Optical rotation were measured at 20°C into sodium light using a Jasco P-2000 polarimeter with a quartz tank with a path length of 1 cm, values are given in deg. dm<sup>-1</sup>.g<sup>-1</sup>. mL<sup>-1</sup> with concentrations reported in g/100 mL.

<sup>1</sup>H NMR, <sup>13</sup>C NMR and <sup>19</sup>F NMR were recorded with Bruker Avance II 250 MHz or an Avance III HD Nanobay 400 MHz spectrometers. CD<sub>3</sub>OD, DMSO-*d*<sub>6</sub> and mainly CDCl<sub>3</sub>, with tetramethylsilane as internal reference, were used as deuterated solvents. Acetone was added in D<sub>2</sub>O NMR samples as an internal reference for carbon NMR. Assignments were based on DEPT 135 sequence, homo- and heteronuclear 2D correlations. Chemical shifts were reported in parts per million (ppm). Coupling constants (*J*) are reported, expressed in Hertz (Hz) and rounded to the nearest 0.5 Hz, splitting patterns are designated as b (broad), s (singlet), d (doublet), dd (doublet of doublet), ddd (doublet of doublet of doublet), t (triplet), dt (doublet of triplet), q (quartet) or m (multiplet). To simplify the NMR attribution, protecting and activated groups have been abbreviated: acetyl group (OAc), benzylidene group (CH-Ph), p-methoxyphenyl group (MP), 2-Naphthylmethyl group (NAP), tosyl group (Ts), trifluoroacetyl group (TFA).

The following solvents have been abbreviated: DCM (dichloromethane), DMF (N,N-dimethylformamide), EA (ethyl acetate), EtOH (ethanol), Et<sub>2</sub>O (diethyl ether), MeOH (methanol), PE (petroleum ether) and THF (tetrahydrofuran).

## 4.2. O-(Methyl- $\beta$ -D-glucopyranosyluronate)-(1 $\rightarrow$ 3)-2-amino-2-deoxy-D-galactopyranose hydrochloride salt (1)

Disaccharide **1** (36 g) was obtained by acid hydrolysis of commercially available chondroitin sulfate A sodium salt from bovine trachea (50 g) using reported procedure.<sup>3</sup>

## 4.3. O-(Methyl- $\beta$ -D-glucopyranosyluronate)-(1 $\rightarrow$ 3)-2-deoxy-2-trifluoroacetamido- $\alpha$ -D-galacto pyranose (4)

Ethyl trifluoroacetate (1.40 mL, 5.9 mmol, 2.0 equiv.) and Et<sub>3</sub>N (0.82 mL, 5.92 mmol, 2.0 equiv.) were added to a solution of crude disaccharide **1** (1.2 g, 2.96 mmol, 1.00 equiv.) in MeOH (7.4 mL, 0.4 M). The reaction was stirred for 1 day at rt. The reaction mixture was concentrated under reduced pressure and the product **4** was obtained after purification by silica gel column chromatography (EA/MeOH/H<sub>2</sub>O: 15/7/1) as a 2/1 mixture of  $\alpha/\beta$  anomers as a white solid (1.00 g).

# 4.4. O-(Methyl 2,3,4-tri-O-acetyl- $\beta$ -D-glucopyranosyluronate)-(1 $\rightarrow$ 3)-1-O-acetyl-4,6-O-benzylidene-2-deoxy-2-trifluoroacetamido- $\alpha$ -D-galactopyranose (3)

Ethyl trifluoroacetate (25.7 mL, 215.2 mmol, 4.0 equiv.) and  $Et_3N$  (14.8 mL, 107.6 mmol, 2.0 equiv.) were added to a solution of disaccharide **1** (21.8 g, 53.8 mmol, 1.00 equiv.) in MeOH (7.4 mL, 0.4 M). The reaction was stirred for 1 day at rt. The reaction mixture was evaporated under reduced pressure and used without any further purification.

Trifluoroacetic acid (11 mL, 143.6 mmol, 2.7 equiv.) was added to a solution of the previous crude disaccharide in benzaldehyde (220 mL, 0.24 M) under argon atmosphere. The reaction mixture was stirred for 1 day at rt then AcONa (23.9 g, 291.6 mmol, 5.4 equiv.) was added at rt and after 30 min

Ac<sub>2</sub>O (65.0 mL, 648.0 mmol, 12.0 equiv.) and DCM/pyridine 1/1 (220 mL, 0.24 M). The reaction mixture was stirred for 1 day then poured into ice. The reaction mixture was extracted 3 times with DCM, then the combined organic layers were washed twice with a saturated aqueous solution of NaHCO<sub>3</sub>, dried over MgSO<sub>4</sub>, filtered and the solvent evaporated under reduced pressure. Sulfur trioxide trimethylamine complex (125 mg, 897  $\mu$ mol, 15 equiv.) was added to a solution of disaccharide **8** (50 mg, 59.8  $\mu$ mol, 1.00 equiv.) in dry DMF (0.5 mL, 0.11 M). The reaction mixture was

stirred for 48h at 70°C then sulfur trioxide trimethylamine complex was added again (83 mg, 598  $\mu$ mol, 10 equiv.) and the reaction then was heated for 24h. The reaction was cooled down to rt, quenched by addition of methanol (2 mL) and stirred 30 min. The crude mixture was directly purified by Sephadex LH-20 (DCM/MeOH 1/1) then by Sephadex SP C25 [Na $^{+}$ ] (DCM/MeOH/H $_2$ O: 9/5/1) to give the desired product **9** (44 mg, 78%) as a white solid.

# 4.15. 2-Naphthylmethyl O-(sodium-β-D-glucopyranosyluronate)-(1→3)-sodium-2-acetamido-2-deoxy-4-O-sulfonato-β-D-galactopyranoside (10)

A cold solution of LiOH 1M (250  $\mu$ L, 250  $\mu$ mol, 5.0 equiv./CO<sub>2</sub>Me) and H<sub>2</sub>O<sub>2</sub> 30% (123  $\mu$ L) was added to a solution of disaccharide **9** (50 mg, 59.8  $\mu$ mol, 1.00 equiv.) in THF/H<sub>2</sub>O 3/1 (2 mL) at 0°C then the reaction mixture was stirred at rt fort 24h. It was then diluted with a solution of methanol/water 3/1 (6.5 mL) and NaOH 4M was added (1 mL, 2.96 mmol, 15 equiv./ester). The reaction mixture was stirred for 48h at rt, then neutralised till pH = 7 with Amberlite IR 120 [H<sup>+</sup>] resin, filtrated, evaporated under reduced pressure and the crude mixture was used without any further purification.

Triethylamine (90  $\mu$ L, 0.64 mmol, 13 equiv.) and acetic anhydride (100  $\mu$ L, 0.99 mmol, 20 equiv.) was added to a solution a previously crude in MeOH/H<sub>2</sub>O 4/1 (5 mL) for 2h at rt. Amberlite IR 120 [H<sup>+</sup>] resin was added to the reaction mixture until pH = 5, then the reaction mixture was filtrated, concentrated and co-evaporated with water 2 times under reduced pressure. Then NaOH 1M was added to the mixture until pH = 10, followed by a purification using Sephadex LH-20. The product was then eluted from a column of DOWEX 50WX4-Na<sup>+</sup> and finally purified using Reveleris® column chromatography on

C-18 reverse phase ( $H_2O/MeOH\ 100/0\ to\ H_2O/MeOH\ 9/1$ ) to give the deprotected dissacharide **10** as a sodium salt (26.9 mg, 82%).

A cold solution of LiOH 1M (267  $\mu$ L, 267  $\mu$ mol, 5.0 equiv.) and H<sub>2</sub>O<sub>2</sub> 30% (130  $\mu$ L) was added to a solution of disaccharide **7b** (40 mg, 53  $\mu$ mol, 1.00 equiv.) in THF/H<sub>2</sub>O: 3/1 (4 mL) at 0°C then rt. After 24h, the reaction mixture was diluted by addition of a solution of methanol/water 4/1 (5 mL) and NaOH 4M was added (800  $\mu$ L, 5.08 mmol, 60.0 equiv.). The reaction mixture was stirred for 48h at rt, then neutralised at pH = 7 with Amberlite IR 120 [H<sup>+</sup>] resin, filtrated, evaporated under reduced pressure and the crude mixture was used without any further purification.

Triethylamine (96  $\mu$ L, 0.689 mmol, 13.0 equiv.) and acetic anhydride (106  $\mu$ L, 1.06 mmol, 20 equiv.) were added to a solution of the crude disaccharide in MeOH/H<sub>2</sub>O: 4/1 (5 mL) for 2h at rt. Amberlite IR 120 [H<sup>+</sup>] resin was added to the reaction mixture until pH = 5, then the reaction mixture was filtrated, concentrated and co-evaporated with water 2 times under reduced pressure. Then NaOH 1M was added to the mixture until pH = 10, followed by a purification using Sephadex LH-20 (water) to give the fully deprotected dissacharide **11b** as a white salt (11.9 mg, 41%).

#### 4.17. 3-Azidopropyl O-(sodium-β-D-glucopyranosyluronate)-(1 $\rightarrow$ 3)-2-acetamido-2-deoxy-β-D-galacto pyranoside (11d)

A cold solution of LiOH 1M (1.62 mL, 1.623mm, 8.5 equiv.) and  $H_2O_2$  30% (1.91 mL) was added to a solution of disaccharide **7d** (128.8 mg, 191 µmol, 1.00 equiv.) in THF (9.5 mL, 0.02M) at 0°C then rt. After 24h, the reaction mixture was diluted with methanol/water 4/1 (27 mL) and NaOH 4M was added (4.78 mL, 19.1 mmol, 100 equiv.). The reaction mixture was stirred for 48h at rt, then neutralised at pH = 7 with Amberlite IR 120 [H $^+$ ] resin, filtrated, evaporated under reduced pressure and the crude mixture was used without any further purification.

Triethylamine (345  $\mu$ L, 2.48 mmol, 13.0 equiv.) and acetic anhydride (382  $\mu$ L, 20.0 mmol, 20 equiv.) were added to a solution of previous crude disaccharide in MeOH/H<sub>2</sub>O: 4/1 (27 mL) and the reaction mixture was stirred at rt for 2h. Amberlite IR 120 [H<sup>+</sup>] resin was added to the reaction mixture until pH = 5, then the reaction mixture was filtrated, concentrated and co-evaporated with water 2 times under reduced pressure. Then NaOH 1M was added to the mixture until pH = 10, followed by a purification using Sephadex LH-20 (water) to give the deprotected dissacharide **11d** as a sodium salt (52.9 mg, 55%).

New chondroitin disaccharide bearing a *N*-trifluoroacetyl group and a benzylidene acetal was prepared on a gram-scale from a semi-synthetic disaccharide. Stereoselective glycosylation could be achieved and allowed the formation of various non sulfated and 4-sulfated disaccharides. The deprotection of the TFA moiety was validated in the presence of aglycons functionalized with azides groups which was not possible with the TCA group used so far.
